Homosexuals counter that increased tolerance is not enough, that the nation owes them protective laws. A good many liberals have bought this argument. But it is possible to doubt that homosexuals are a class of citizens entitled to such legislation. The government's function is not to guarantee jobs or apartments for every disaffected group in society but only to step in where systematic or massive discrimination requires it. That is clearly not the case with homosexuals.

The homosexual complaint is a claim that homosexuals should not have their private behavior judged when it enters the public arena. No group in America enjoys that protection under the law. "It's a life-style question," said one opponent of a gay rights law. ... "We've never seen legislation passed to protect a life-style." ... in a free society, employers and landlords are granted considerable latitude in taking into account all publicly known aspects of an applicant's character and behavior. The problem is that laws passed for blacks and women are not currently viewed as rare exceptions to the general rule that employers and landlords can hire or rent to whom they please. The Government has better things to do than proliferate categories of unemployable citizens. Like Masons, millenarians and est graduates, homosexuals must take their chances in the marketplace, just as everyone else does. It owes them fairness, but not the kinds of legislation sought by gay groups. The best public policy toward homosexuals is no public policy at all.


To deny this ... to a gay militant is not a violation of his civil rights. To compare his situation to that of oppressed blacks in this country is ideological fantasy.

On April 26, 1980, CBS News aired a nation wide documentary on the impact of "Gay Power" politics on the City of San Francisco. The impact of Gay political domination on the character and quality of life in neighborhoods, schools and other public places was clearly pictured. Not a pretty picture either.

Gays advocating the funding to teach homosexuality as an "accepted" lifestyle in schools.

Gays openly taking over a public city park for their own private use, where sex is common place and threats were made to children who innocently observed these acts.

Gays call for hiring quotas, especially in the police department which already has a gay recruitment specialist.

And politicians afraid to stand up to militant gay activists. In fact, in a recent newspaper article, a prominent San Francisco gay leader said: "We can choose who gets elected in this city. Gay support means success at the polls—opposition means defeat."

What is established fact in San Francisco is now being seen and experienced here in Santa Clara County. Over 2 years ago militant gay activists (by their own admission) laid out a strategy aimed at reproducing their political domination of San Francisco here in San Jose and Santa Clara County. First came Gay Pride Week. Then last year they ramroded through their so-called "gay rights" ordinances. Ordinances that allow them to flaunt their sexual lifestyle publicly; and which force us to hire, live with, or do business

with them irrespective of our personal values or beliefs.

Our community was shocked by this political action. In less than one month over 100,000 concerned citizens signed petitions to place these measures on the ballot.

On June 3rd you will be asked to decide if you want "Gay Power" as a permanent political force in our City and County.

The pro-gay supporters of Measures A & B are running an expensive (over \$250,000) media campaign to convince you that it's a simple matter of "live and let live". But don't be deceived. Gay leaders from all over America have contributed hundreds of thousands of dollars to win this crucial test of their political muscle.

If A & B are passed it's just the beginning. In fact, at a recent forum for San Jose City Council candidates, leaders of the Yes on A & B Campaign said, "These ordinances are just the beginning. We also want Gay hiring quotas in all public and private employment. We demand Gay enrollment programs and Gay Studies Departments in our colleges. And we insist on our right to have the homosexual lifestyle taught in high schools as an acceptable alternative."




